CRYPTO + TAXES

There is a lot of confusion surrounding virtual currency and the taxation of buying, selling and exchanging these assets. Virtual currency transactions are taxable by law including using virtual currencies to pay for goods or services.

FAQ's

Q. Must a taxpayer who receives virtual currency as payment for goods or services include in their gross income?

A. Yes, based on the fair market value (FMV) on the date received based on on US dollars. (Payments over \$600 in virtual currency for services or rents are subject to 1099-NEC reporting)

Q. Does a taxpayer have gain or loss upon an exchange of virtual currency for other property?

A. Yes, if the FMV of property received in exchange for virtual currency exceeds the taxpayer's adjusted basis (price paid) of the virtual currency, the taxpayer has a taxable gain. If the FMV is less than basis, there is a loss.

Q. Does a taxpayer realize a gain or loss when they use virtual currency to pay for goods or services?

Yes. The gain/loss is calculated based on the difference in basis vs. FMV at time of payment for goods or services

.The most important thing to keep in mind with your crypto and taxes is that any time you sell, exchange for another coin, or use to pay for goods or services, it is a taxable transaction that ill need to be reported on your tax return.
