## Tips for E-mail Etiquette

I have a LOVE/HATE relationship with e-mails. Yes, I find them to be an effective way to communicate and is helpful to save them to refer back to at a later date. Also, I have had to use as a CYA at times to verify that I did inform so & so of something, etc. During this time of year, our e-mail inboxes are flooded with e-mails. and literally, I receive over 1,000 e-mails per day - not including Spam e-mails. So....I thought this week's topic would be about E-mail etiquette!

- Don't respond to an e-mail when emotional
- Proofread your emails
- Check that you are sending to correct recipient
- Keep E-mails concise - Use Bullet points & avoid long sentences
- Remember to set up out of office messages if you will be out of the office

- Use Group E-mails selectively and refrain the temptation to reply Thank you to every message you get - can cause e-mail clutter
- Schedule e-mails for time appropriate to be sent
- Refrain from sending multiple e-mails about the same issue - only further delays reply time and e-mail overload problems
- Remember there are other ways to communicate - pick up the phone or text to make sure that your email has been received and to see when to expect a reply

- **March 1, 2022: Homestead Exemption Filing Deadline - if you purchased a new primary home in 2021, you should apply for homestead exemption for your 2022 property taxes**
- **March 15, 2022: S-Corporations and Partnership Returns are due or extensions must be filed \*\*\*We will be protective filing extensions for all business clients that we do not have your information yet or we do not have your signed e-file authorization form**
- **March 31, 2022- Last day to pay your Real Estate Taxes!**
- **April 1, 2022: Florida Tangible Property Tax Returns due**



**\*\*IMPORTANT\*\*** If we receive your information after April 1st, we will be filing protective extensions in the event we are not able to complete your return prior to the April 15th deadline

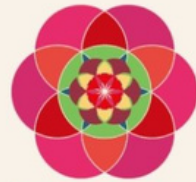
- **April 15, 2022: Individual, Trust & C-Corporation returns are due**
