## POST TAX SEASON UPDATE!

Thank you for your patience and support this tax season as it was our busiest one yet!

Here are a few post tax season updates & tips:

- **To check your refund status**, please visit: <https://www.irs.gov/refunds>
- **If you owe and are not able to pay in full**, you should set up an installment agreement if you will need longer than 6 months to pay. You can do this online as long as the total balance owed to the IRS is less than \$75,000 by visiting this website: <https://www.irs.gov/payments/online-payment-agreement-application>
- **If you receive a letter from the IRS**, please take the following steps:
  - E-mail the letter (all pages) to [Shyann@ Shuggins@d-acpa.com](mailto:Shyann@Shuggins@d-acpa.com)
  - Please allow us 1-2 weeks to review the letter and reply to you regarding next steps to take

\*\*\* IF THE IRS NOTICE IS CP11 (located in upper right hand corner) this is in regards to the 3rd round of stimulus payments that were reported on your tax return. This was \$1,400 per person that was on the 2020 tax return and was sent to most taxpayers in March/April 2021. PLEASE check your bank statements to confirm the amount you received prior to sending the letter to us. In most cases, the amount reported on your return was per the questionnaire that you answered or per the IRS notices you had provided to us

- If you have sent your tax documents to us and we have filed the extension for you, we are working on the returns in the order that your information was received. For a status of your tax return, please send us a text message to 561-659-1177 and we will reply as soon as possible.

## ARE YOU INTERESTED IN A SBA EIDL LOAN INCREASE?

You may be eligible for an increase in your SBA COVID-19 Economic Injury Disaster Loan (COVID EIDL) amount, subject to SBA analysis.(Please disregard this notice of a loan increase if you have already submitted your increase request.) If you are interested and you have not reached your maximum eligibility, **please apply by May 6, 2022**, which is the last day to submit any loan increase or reconsideration requests for COVID EIDL. Each request is processed in the order received and is subject to availability of funds. The steps to request an increase are:

1. Confirm your loan eligibility and review the FAQs.
2. Log onto your Account on the SBA Portal (do not apply for another loan) to submit a loan modification request.
3. Complete the portal steps and submit relevant documents, including a new version of your IRS Form 4506-T for COVID EIDL.
4. Respond to SBA requests for signature and documents by May 16. The failure to sign and submit documents prior to funds being exhausted/rescinded will result in no increase.
