

JULY 15TH


- 2nd Quarter Payroll tax deposit due

IRS Refunds:

The IRS has announced that refunds are being delayed and to check [IRS.gov/refunds](https://www.irs.gov/refunds) for updates. The IRS has stated that it could take 10-12 weeks for refunds to be processed. You can check the status of your refund online at [irs.gov/refunds](https://www.irs.gov/refunds), The IRS has flagged over 5 million returns in 2021 so your return may either not show on the IRS site or show as processing for a few months.

Tax Refund Adjustments:

If you receive a reduced refund it may be due to an adjustment due to Round 1 and/or 2 of your Economic Impact Payments reported on your tax return. You should check your bank account to confirm amount actually received for these payments.
